### FOR CRAFT/PRODUCTS/SERVICE VENDORS:

If you would like to sell your products and/or services, we are looking for island type products, such as: flower leis, Ipus, Poi balls, sarongs, Toere drums, music cds, books, jewelry, clothing, etc. There will be table space available. Please, make sure you have the necessary licenses and/or permits to sell your products/services. See above \*For All Vendors.
